WHAT IS TAXATION

Taxation

Def This is how the Government collects money from people and business which is then used to pay for public services.

The office of the revenue commissions looks after the assessment and collection of tax in Ireland. It is also known a Revenue.

The money collected is used by the government to run the country and to provide important services like build roads and schools and to pay the wages of teacher and doctors. The taxes collected include the following -

- 1. Tax on income PAYE, PRSI and USC
- 2. Corporation tax on companies' profits (12.5%)
- 3. VAT on goods and services (23%)
- 4. Excise duty on petrol and diesel

PRINCIPELS OF A TAX SYSTEM

A fair tax system should have the following -

- 1. Equality The tax the person pays should take into consideration their ability to pay the amount.
- 2. Certainty The person should know how much tax they are paying. It should be clear and predictable the same each time.
- 3. Economy The cost of collecting the tax should not be more that how much is collected.
- 4. Convince It should be easy to pay the taxes when they are due.

The purpose of Taxation

Tax should not be a disincentive. This means that that is taxes are too high people may not work because they will be given away most of their wage to Revenue in the form of a tax.

A fair tax system is when the government charges tax to the higher earners in a country and then redistributes it to the less well off

THE PURPOSE OF TAXATION

Taxes are used for the following reasons - 1. Financial, 2. Social, 3. Legal, 4. Ethical

1. Financial

Financial reasons include the following -

- 1. Provide and revenue for the Government.
- 2. For economy purposes control inflation.
- 3. Aid enterprise Provide grants.
- 4. Repay the national debt (servicing).

2. Social

Social reasons include the following -

- 1. Redistribute wealth provide less well off (social welfare payments)
- 2. Discourage bad behaviour tax on tobacco.

3. Legal

Legal reason Included -

1. It is compulsory under Irish law.

4. Ethical

Ethical Reason Included

1. Fairness - applies to everyone depending on their ability to pay.
